NOTE TO ANY/ALL U.S. INSTITUTION OF PUBLIC ACCOMMODATION to include: school, church, medical facility, group home, hospital, store, restaurant or bar, gov't building, recreation area, etc. Regarding your requirement that attendees wear a medical device called a mask or receive a Covid Vaccine or Covid test, issued under emergency use authorization (EUA) experimental use only. As I, and/or my family may be entering your place of public accommodation, I am requesting that you review this document, provide the requisite information, and sign the form.

## The mandate for any individual to wear a mask, take the shot or a test for Covid VIOLATES FEDERAL LAW

This serves as notice that the mandate for any individual to wear a mask against COVID-19 for employment or attendance at a university, other school, place of employment, or other institution violates federal law. All COVID-19 masks, (whether surgical, N95 or other respirators), PCR (or other) tests for Covid, and Covid vaccines, are authorized, <u>not</u> approved or licensed, by the federal government; they are Emergency Use Authorization (EUA) only. They merely "may be effective." Federal law: Title 21 U.S.C. § 360bbb-3(e)(1)(A)(ii)(I-III) of the Federal Food, Drug, and Cosmetic Act (FD&C Act) states: individuals to whom the product is administered are to be informed— 1,2

- (I) that the Secretary has authorized the <u>emergency</u> use of the product (only);
- (II) of the significant known and potential benefits and <u>risks</u> of such use, and of the extent to which such benefits and risks are unknown; and
- (III) of the option to accept or refuse administration of the product, of the consequences, if any, of refusing administration of the product, and of the alternatives to the product that are available and of their benefits and risks.
- NYS Law prohibits all places of public accommodation (Health clinics and hospitals, Hotels and motels, Movie theatres and music halls, public buildings, schools, and government offices, restaurants and barrooms, Retail stores, etc.) from discriminating based on a person's disability. A sizeable number of people have breathing or anxiety disabilities which preclude mask-wearing. A significant number of people have allergies that prevent them from wearing a mask or taking the vaccine ingredients into their body. For many, the vaccine ingredients may send them into shock and potentially death.
